## **REGISTRATION PROCEDURES:**

Please register the child on the relevant date/venue and bring along the following:

- (a) Duly filled Registration Form  
(Registration form to be downloaded and printed out in **double sided format** from our website at [www.akg.edu.sg](http://www.akg.edu.sg));
- (b) One recent passport size photograph of the child;
- (c) Non-refundable Registration fee of \$60.00 payable in cash or cheque to **“The Ascension Kindergarten”**;
- (d) For Long-Term Pass/Visit Pass/Foreign student, an additional non-refundable administrative fee of \$60.00 for the application of Student Pass which will take place in October 2019;
- (e) Relevant documents as below:

If parents are unable to personally submit the registration form and photocopies of the relevant documents, they may authorise another person to submit the documents on their behalf.

**NOTE: For existing children in our kindergarten, they will be promoted automatically. There is no need for re-registration.**
